Thredbo Hot Laps Promotion

Terms & Conditions

1. Information on how to enter and the prizes form part of these Terms & Conditions. Entry into this Promotion is deemed acceptance of these Terms & Conditions.

2. Parties include:

- 3. The Promotion commences at 8:30am (Sydney time) on 11/12/2025 and closes at 5:00pm (Sydney time) on 27/4/2026 ("**Promotion Period**").
- 4. The Promotion is open to individuals who:
 - i. are residents of Australia:
 - ii. are aged 7 years of age and older. Any entrant under 18 years of age must obtain permission from their parent or guardian prior to entering this Promotion;
